It has been my understanding that I was to be called to testify regarding the Murrah Federal Building Bombing. As yet, I have not received any summons.


I can identify two men seen in the Murrah Building the morning of the bombing as approximately 8:15 a.m. as well as the day prior to the bombing. These men in appearance were dressed like the GSA maintenance men but were not GSA employees..

I would have thought that this information **was of sufficient importance** to the Grand Jury that I would have been called by now to testify regarding information that I have. It is my duty to report this information to you for investigation so that the truth can be obtained regarding the bombing.

I am therefore, **demanding that I be called immediately** as a witness to provide to the Grand Jury all information that I have relating to the bombing.


I look forward to your assistance in resolving this matter as expeditiously as possible.

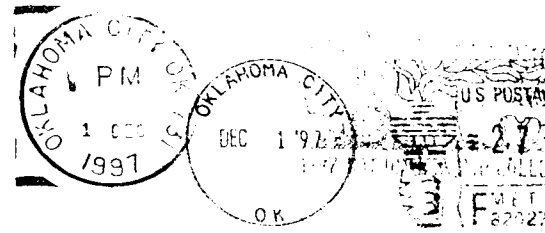
