Dear Sirs,

Please be advised of this formal Complaint. The felonies concerning the Waco, Texas Davidian Seige (Farm Road 2491 from Route 340) and related matters described herein are within your jurisdiction, as Texas Federal Grand Juries and associated Federal Grand Juries scrutinizing same have and/or will determine. Exhibit "ONE" annexed hereto is the related Constitution Coalition Press Release and Press Package delivered personally to the Waco Assault site. Exhibit "TWO" annexed hereto are related 17 pages regarding the indictments of Delroy Nash, Margaret Lawson and Catherine Mattson. Exhibit "THREE" annexed hereto is the relevant Declaration of Dr. Michael Bradley, to which is annexed the also enclosed Complaint, Civ. No. 3-93CV0440-X and filed in the United States District Court for the Northern District of Texas. Exhibit "THREE" includes a discussion of the reasons for the Waco, Texas Seige. Remember, the Federal Grand Juries are the FINAL TRIBUNAL over your actions, and you are under their scrutiny as you read this, see Fifth Amendment of the U.S. Constitution, re: Presentment. Texas Governor Ann Richards has been served with a Federal Warrant for Citizen's Arrest for failing to preserve Texas authority rather than giving same (for these matters) to Federal officers and agents. Texas should have control over the Waco, Texas seige because Texas is a sovereign Republic; and this letter assists in immediate completion of same; which will result in saving lives now. According to the the U.S. Constitution, everyone should be secure from being murdered by federal officers and agents while in their own home.
